September 30, 2021 Treasurer's Report and ARC Update

Bill Dennehy, of Chandler Asset Management, presented an economic update for November 30, 2021, along with the Treasurer's report and portfolio performance with supporting schedules for both PRISM and ARC. Mr. Dennehy answered the Committee's questions on the material presented.

2021 Annual Comprehensive Financial Report (ACFR)

Staff reviewed the ACFR with the Committee including a review of the combined and individual program financial statements and the required supplementary information. Bob Green, with Gilbert CPAs, presented their audit opinion, which was unmodified, their Report on Internal Control, which had no recommendations or findings, and the Communication with Those Charged with Governance. The Committee recommended that the Executive Committee and the Board of Directors adopt the Budget Revision Resolution.
