## York SIMS Go-Live

In January 2014, the EIA implemented a new claims management system (CMS), SIMS, created by Systema. A long-term goal was to convert the TPAs who handle claims for the PWC and PGL programs to SIMS. During the past year, EIA staff and Systema personnel have worked with PWC TPA York to convert York to SIMS for EIA matters.

The go-live date for this conversion is next Wednesday, April 1, 2015. As a part of the go-live process, the EIA's CMS will be inaccessible from Saturday, March 28 until Wednesday morning of April 1st. If you anticipate you will need any information regarding a claim during that time, please plan accordingly and contact EIA staff before close of business Friday, March 27 for the information.
